LESTER PUBLIC LIBRARY BOARD OF TRUSTEES MEETING

President Patrick Gagnon called the meeting to order at 7:00 PM.

Members Present: Patrick Gagnon, Rick Henrickson, Robert Fay, Brenda Krause, Kirsten Miller, Jay Orvis, Sharon Stone, and Teri Wagner. Absent & Excused: Joyce Beth and Terry Schumacher. Also Present: Director Jeff Dawson, Adult Services Coordinator Chris Hamburg, City Councilmember Vince Alber, and Tower Square Investment advisors Tony Carini & Gary Nadolsky.

Public Comment - Mr. Gagnon recognized Vince Alber and asked if he had something he wanted to address with the board. Mr. Alber stated he attended to observe.

Invited Guests – Gary Nadolsky and Tony Carini of Tower Square Securities, Inc. presented the members with the current performance of Library gift fund investments. Mr. Gagnon stated he was unhappy with the returns at this time. Councilmember Jay Orvis questioned the prudence of investing in lieu of putting the funds in conservative holdings, and if the board would consider security over growth for these funds. Mr. Carini & Mr. Nadolsky stated the risk of pulling funds out would be loss of the ability to recoup previous losses. Carini & Nadolsky illustrated performance by using scenarios during historic market downturns. Mr. Fay added the importance of watching the next quarter. Brenda Krause agreed that the past 3 months have produced unforeseen results. Councilmember Alber added that the performance of the funds is better than the market as a whole. President Gagnon thanked Carini and Nadolsky for the presentation.

Mr. Gagnon noted the cancellation of the December 2008 meeting. Moved by Rick Henrickson accepting the November 11, 2008 meeting minutes, Teri Wagner seconded the motion. Voice vote carried unanimously.

Moved by Brenda Krause approving the October and November 2008 financial statements as presented, Sharon Stone seconded the motion. Voice vote carried unanimously.
